#### The Des Moines Modelaires - General Membership Meeting Minutes

#### June 2, 2015

The meeting was held at the club's West Field in Grimes. The meeting was called to order by club President Alan Annear at approximately 7:00pm. There were 14 members present.

The Secretary read the minutes of the last General Membership meeting which were accepted.

In Denis' absence, Alan reported that the club now has 109 full members and 12 youth. He also reported that the mower cab was sold for \$600.00, and that Denis reported that with that sale, and the fun fly landing fees, the club was set to break even or make money this year.

#### Old Business:

The summer training nights have begun, with the first night bringing about 6 new flyers. The number of volunteers at this time is sufficient but Ben Erickson has invited more people to volunteer so that each person will not have to be there every week.

Tim Nissen reported that he was in contact with the Elkhart people concerning the Elkhart Fun Day Demo for more coordination in that program.

#### New Business:

The club gained \$110.00 net from the Multi-Wing Fun Fly.

The Board voted to forego any more Weed and Feed until 2017. Broadleaf weed control will still be applied.

Alan reminded all that the Board is reviewing the bylaws and will present a proposed revision soon for club appraisal and vote.

Alan indicated that he will host a Fun Fly on August 15<sup>th</sup> for National Model Aviation Day. There will be a landing and lunch fee which will be donated to the Wounded Warriors Program. He is also contacting news media and TV stations for publicity. Keith Page volunteered to help with this program.

October 24<sup>th</sup> will be the 2015 Swap Meet and Auction. Alan reported that the Board has set the fees: Buyers ticket fee will be \$5.00 and a Swap Table ticket will be \$10.00. The club will need volunteers. Ray Pick is heading up the Auction / Swap Meet. Please contact Ray or Alan to volunteer.

Upcoming events were discussed which will be separately listed in the newsletter.

Bill Garrett thanked the club for the remembrance the club gave in honor of his father.

Dave Beecher, who helped author several articles for the newsletter, pointed out that Denis would really appreciated more articles by members. Contact him if you have any ideas.

Lacking further business, the meeting adjourned at 8:15 PM.

## **Current Bylaws**

# DES MOINES MODELAIRES BYLAWS

#### Article I

Officers

The officers of the Des Moines Modelaires Club shall be:
(a) A President
(b) A Vice-President
(c) A Secretary
(d) A Treasurer
(e) A Board of Directors of six (6) members, and all elected officers and the past President

#### Article II

Officer Duties

The responsibilities of the club officers and directors:

(a) President- The President shall preside at all meetings of the club and shall act as spokesman for the club in all matters pertaining to the club.

(b) Vice-President- The Vice-President shall act for the President when he is unable to serve, and function as chairman of the program committee.

(c) Secretary- The Secretary shall keep the minutes of all meetings and the attendance roll of such meetings. He shall provide himself with an official minute book for this purpose.

(d) Treasurer- The Treasurer shall collect all monies due and shall keep a record of all monies received and monies disbursed by the club.

(e) Board of Directors- The Board of Directors shall act on all matters of general policy.

#### Article III

Terms of office:

Terms of office and election matters:

(a) All officers of the Des Moines Modelaires Club shall serve for one year from date of election.

(b) All Board members shall serve for a period of two years. Three members shall be elected in even numbered years. The other three members shall be elected in odd numbered years.

(c) The annual meeting and the elections of officers shall be held annually at the regular meeting in December of each year and the nominations shall be made by a committee appointed beforehand for that purpose or by individual members following the report of the nominating committee.

#### Article IV

#### Vacancies

Vacancy in any office shall be filled by appointment by the Board of Directors. Such appointee to serve until the end of the term for which his predecessor was selected.

#### Article V

#### Meetings

Regular meetings shall be held each month on a day decided by the officers. Special meetings of the club shall be at any convenient time, upon call by the President or upon call signed by any three members of the Board of Directors, or upon call signed by any ten members of the club, provided that any such call shall name the time and place of such meeting, and shall be issued at least three days in advance of the date set. Notice of regular meetings will be given in the club newsletter. Members will be notified by the club newsletter of annual election meetings a week in advance. However, failure to notify the members in advance shall not nullify any election procedures conducted at any meeting where a quorum is in attendance as stipulated in Article VI (b).

#### Article VI

**Regular Business** 

Modelaires business meetings rules.

(a) All regular business affairs and enterprises conducted by the club shall be directed by the Board of Directors, except that at any time the President or the Board may call a meeting of the membership to decide on any problem of business activity.

(b) A quorum shall consist of one more than fifty percent of paid membership present at a club meeting. At any Board of Directors meeting, a quorum shall be fifty percent of the Board's personnel.

#### Article VII

Dues and Fees

The collecting and setting dues for the Des Moines Modelaires Club.

(a) All persons living in the Greater Des Moines central Iowa area are eligible for membership in the Des Moines Modelaires Club in one of the following categories:

(1) **Flying Membership**-An applicant holding a current Academy of Model Aeronautics membership and who pays the club annual dues and assessments, if any, will be issued a flying membership card that entitles them to full use of all of the Modelaires flying fields and voting privileges and the possibility of holding any office in the club. They will receive the club newsletter.

(2) **Supporting Membership**-Upon payment of the current club dues a non-flying membership card will be issued. No AMA membership will be required. At no time will a non-flying cardholder be allowed to fly at any Des Moines Modelaires fields. The non-flying cardholder will not have voting privileges and cannot hold any office. They will receive the club newsletter and are encouraged to attend meetings and come out and watch the flying and attend and socialize at all Modelaires events.

(b) Annual membership dues and field dues shall be adjusted according to the financial needs of the club and approved by vote of those present.

(c) No special assessment shall be levied upon the club membership at any time, except by vote of the

paid membership, and then only upon majority vote of those present.

#### Article VIII

#### Special Funds

The Treasurer of the club is authorized to receive contributions or specially obtained funds from any individual or institution, to be applied to the operating expenses of the club.

#### Article IX

All flying members of the Modelaires are required to join the AMA

#### Article X

#### Amendments

Amendments may be made to these By Laws at any general meeting of the club membership, provided the members shall have been notified in writing at least three days in advance that an amendment is to be considered.

Copies of the proposed amendments shall be provided to all directors or to any members who may request the same.

# **Proposed Bylaws**

#### DES MOINES MODELAIRES BYLAWS Effective August 2015

#### Article I

The Officers of the Des Moines Modelaires Club shall consist of a:

(a) President

- (b) Vice-President
- (c) Secretary
- (d) Treasurer

All Club Officers must be current and paid club members.

#### Article II

The Board of the Des Moines Modelaires shall consist of:

All Officers, six (6) current and paid club members, and the past President assuming the past President is a current and paid club member and willing to participate on the Board.

#### Article III

Officer and Board Member Duties and Responsibilities:

(a) President- The President shall preside over all meetings of the club including Board meetings and shall act as spokesman for the club in all matters pertaining to the club. The President has discretion over routine and necessary decisions concerning club business.

(b) Vice-President- The Vice-President shall act for the President when he is unable to serve, and facilitates hobby related programs at general club meetings.

(c) Secretary- The Secretary shall keep the minutes of all meetings and the attendance roll of such meetings. They shall maintain an official minute book for this purpose.

(d) Treasurer- The Treasurer shall collect all membership dues and other club income and shall keep a record of all monies received and monies disbursed by the club. The Treasurer is also responsible for keeping track of club membership and distributing ID cards to paid members.

(e) Board - The Board shall act / vote on all matters of general policy.

(f) Any Officer or Board member may be removed from their position if they have missed three (3) consecutive Board meetings without just cause, repeatedly conducts themselves in a manner harmful to the Modelaires or have let their club membership lapse. Removal from the position will be by vote of the remaining Officers and Board members.

#### Article IV

Terms of office and election matters:

(a) All Officers of the Des Moines Modelaires Club shall serve for two years from date of election. The offices of President and Secretary shall be elected in even numbered years and the offices of Vice-President and Treasurer shall be elected in odd numbered years.

(b) All Board members shall serve for a period of two years. Three members shall be elected in even

numbered years. The other three members shall be elected in odd numbered years.

(c) To facilitate the transition of office, the past club President shall be asked to serve on the Board for a term of one year after their final year as President assuming they are a current and paid club member and they are willing and able to serve.

(d) The annual meeting and the elections of Officers and Board members shall be held at the regular meeting in December of each year. Current and paid club members can self nominate or nominate other club members. All nominations are to be distributed to the current general membership prior to the December club meeting.

(f) Eligibility for nomination and election to any Officer or Board position, and to hold that position, requires that they are a current and paid club members as of February 1st and for the duration of the term they are elected to. If they are not a current and paid club member in the Modelaires by February 1st, they must forfeit the position they were elected to.

#### Article V

#### Vacancies

Vacancy in any Officer or Board position shall be nominated by the club President and voted on by the club Board. Such positions will serve to the end of the term for which their predecessor was selected. If the club President becomes the vacancy the nomination will be made by the current club Vice President, who has assumed the office of President for the remainder of the term.

#### Article VI

Meetings

Regular meetings shall be held each month on a day decided by the club Officers.

Notice of regular meetings will be published in the club newsletter or by email to current club members.

Club members will be notified via the club newsletter or by email to the current club membership of annual election meetings at least one week in advance. However, failure to notify the members in advance shall not nullify any election procedures conducted at any meeting where a quorum is in attendance as stipulated in Article VI (b).

Special meetings of the club shall be at any convenient time, as decided by the club President and other available Officers' or by at least three current Board members, or by any ten club members. The meeting time and place shall be published in the club newsletter or distributed to the current club membership via email at least three days in advance.

#### Article VII

**Regular Business** 

Modelaires business meetings rules.

(a) All regular business affairs conducted by the club shall be directed by the Board, except that at any time the President, or the Board, may call a special meeting of the membership to decide on any problem of business activity.

(b) A quorum shall consist of one more than fifty percent of paid membership present at a club meeting. At any Board meeting, a quorum shall be fifty percent of the Board's personnel.

(c) The Board may approve financial expenditures up to \$500 for any non-budgeted expense. Any non-budgeted expenditure above \$500 shall be taken to the General membership for vote of approval.

#### Article VIII

Dues and Fees

The collection of, and setting of, dues and fees (such as Landing Fees) for the Des Moines Modelaires Club.

**Membership**- An applicant holding a **current** Academy of Model Aeronautics membership and who pays the club annual dues and assessments, if any, will be issued a flying membership card that entitles them to full use of all of the Modelaires flying fields, voting privileges, and the possibility of holding any office in the club. They will also receive the club newsletter via email when published.

(a) Membership types and dues shall be per the Membership Application which will be reviewed annually.

(b) Annual membership dues shall be adjusted according to the financial needs of the club and approved by vote of the general membership present at the club meeting which such vote is taken. Any change in club dues will be published via the club newsletter or via distribution to the current club membership via email and voted on at the August General Membership meeting.

(c) No special assessment shall be levied upon the club membership at any time, except by vote of the current and paid club membership upon majority vote of those present at the club meeting such vote is taken.

#### Article VIIII

#### Special Funds

The Treasurer of the club is authorized to receive contributions or specially obtained funds from any individual or institution, to be applied to the operation of the club.

#### Article X

#### Amendments

Amendments may be made to these By Laws at any general meeting of the club membership, provided the members shall have been notified via the club newsletter or email at least three days in advance that an amendment is to be considered.

Copies of the proposed amendments shall be provided to all Officers and Board members and to any members who may request the same.


